Introduction

We collect and manage your personal information as described on this page, unless stated otherwise. 'Personal information' may include your name, address, phone number, email address, age, gender, your employer, and your position title.

Collection of Information

Using the Calisthenics Buderim website, we may require information from you to provide the best service possible. All correspondence may also be collected and stored, particularly regarding sales, support, and accounts, including Email. Any information collected by Calisthenics Buderim is collected via correspondence from you. This may be via the telephone, Email, mail, messenger, text or directly through our website.

Use of Collection Information

Any details collected from Calisthenics Buderim members, volunteers and parents is required to provide you with our products and/or services, and a high level of customer service. Correspondence is recorded to provide service references.

Storage of Collected Information

The security of your personal information is important to us. When you enter sensitive information (such as credit card numbers) on our website, we encrypt that information using secure socket layer technology (SSL). When Credit Card details are collected, we simply pass them on to be processed as required. We never permanently store complete Credit Card details. We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it.
