Termination, Cancellation and Refunds Policy

Where the injury or illness occurs independent of Calisthenics Buderim activity and preventing ongoing attendance. You may terminate your membership at any time on the following basis:

- You provide a request for termination of your membership in writing to Calisthenics Buderim Inc

You may make a request for a refund on the following basis:

If your request for refund is for reason of permanent sickness or physical incapacity and this prevents you from doing Calisthenics:

- Your request must be accompanied by a medical certificate evidencing such permanent sickness or physical incapacity; and there will be a refund of any unused Membership Fees.
- In the event of death, your estate must provide written evidence in the form of a death certificate and all unused Membership Fees will be refunded.
- Registration and Insurance fees for QLD Calisthenics (CAQI) and Australian Calisthenics (ACF) are non-refundable.

If your request for termination is for reasons other than permanent sickness or physical incapacity:

In relation to Direct Debit Memberships:

- you must provide Calisthenic Buderim with Written Notice of termination at least twenty-eight (28) days before your direct debit bill date; any refund of unused Membership Fees will be considered on a case-by-case basis.

In relation to Pay-in-Full Term Fees:

- you may not terminate the membership during the prepaid period (any refund of unused Membership Fees will be considered on a case-by-case basis), unless you suffer from a permanent sickness or physical incapacity as described above

Termination, Cancellation and Refunds Policy

Calisthenics Buderim may restrict your membership at any time on the following basis:

- concern for the health and/or safety of the member; or
- non-compliance, improper or harmful conduct engaged in by the member.

Calisthenics Buderim may terminate your membership at any time on the following basis:

- you fail to make any payments of your Membership Fees.
 - any fortnightly payments of fees are late.
 - Calisthenics Buderim reasonably suspects that you are engaging in illegal activity in the Club.
 - you fail to follow any of the Policies or Club Rules, or violate any part of this Agreement; or
 - your conduct is improper or harmful to the best interest of Calisthenics Buderim members.

- In the event Calisthenics Buderim terminates your membership termination will be effective on the date that Calisthenics Buderim sends Written Notice. You are liable for all financial obligations until that date. If you are a Pay-in-Full term member, Calisthenics Buderim will not refund any unused portion of your fees.
 - Upon termination of your membership by Calisthenics Buderim, you will cease to have access to the Club. Any money owing to Calisthenics Buderim when your membership ends, remains immediately due and payable and Calisthenics Buderim will deduct the amount outstanding from any refund which you may be eligible. If there is not enough money to cover the amount owing to Calisthenics Buderim, you must pay the balance of the amount owing.
 - Termination or expiration of this Agreement shall be without prejudice to the rights of each party against the other in respect of anything done or omitted under this Agreement prior to such termination or expiration.
